

Each year, St. Mary Parish is audited to verify our compliance with Archdiocesan policies in the area of providing a safe environment for all of our children. You are receiving this letter because you are new to a ministry area having this requirement or because we are missing either the written acknowledgement form or have no verification that you have participated in an "awareness session". We are following Archdiocesan guidelines which require some things of us and some of you. What's required is:

1. **The parish** is required to have criminal background checks on file for each person who has regular contact with minors. These records are to be rechecked every five years. The pastor, along with the appropriate supervisor would normally see the results of the check and make the appropriate decisions. If you do not want us to perform such a check, please advise me immediately. We will refrain from doing so at your request and you are not allowed to continue in your ministry with children.
2. **You** need to complete a Volunteer Enrollment Form or an Application for Employment and send it to the parish office.
3. **You** need to read two Archdiocesan documents: *Code of Ethical Standards and the Mandatory Reporting Responsibilities Policy.*
4. **You** must attend a three-hour facilitated SEE (safe environment education) session" about childhood sexual abuse and creating a safe environment, using program materials provided by the Archdiocese. However, if someone feels that they should be excused from this requirement (attending a Safe Environment Education session), they should write a letter to Archbishop Dolan explaining the circumstances and requesting a waiver from this requirement.

**Regarding item #2:** A Volunteer Enrollment Form and/or an Application for Employment is included for your convenience.

**Regarding item #3 and #4:** Everything is available on-line. Go to the Archdiocesan website ([www.archmil.org](http://www.archmil.org)) and then to the link Safeguarding All of God's Family. You can download these documents to read and you can sign up to attend an awareness session.

**After you have read both documents, complete the Acknowledgement form at the bottom of this letter and return it to the parish office.**

**Regarding item #4:** You must pre-register by computer so that your awareness session attendance can be verified and so that you receive credit for fulfilling this mandatory requirement. Each session is open listed, meaning that all awareness sessions are available to any registrant. If the maximum capacity for a specific awareness session has been reached, you will be prompted to select a different session.
